

### Terms to Know

**General Education Recovery Support:** may be made available to students with and without disabilities who need it to address educational and social-emotional needs and reorient them to learning (e.g., District Curriculum Accommodation Plan--DCAP)

**COVID-19 Compensatory Services (CCS):** for students with IEPs to remedy skill or knowledge loss or lack of effective progress due to delayed, interrupted, suspended, or inaccessible IEP services— decisions to be made no later than December 15, 2020

**New IEP Services:** to address new areas of disability-related need for students with IEPs

# B. Updates from the Department of Elementary & Secondary Education

- DESE is providing supplemental guidance and recommendations to ensure equitable access to learning for English Learners with disabilities during in-person, hybrid, and remote learning
- Guidance can be found on the English Learners section on DESE's COVID-19 pages
- IEP Improvement Project stakeholder group is reviewing guidance documents
- MA dyslexia guidelines anticipated to be released in mid-November

# C. Tools for Tracking Remote Learning Participation & Prompting

- Caregivers are now often in the best position to report student's performance level
- Document if and how you are assisting your child with work, modifying expectations, prompting, editing, etc.
- Note time to task completion
- Identify barriers or bridges to participation
- Share this data with the team
- Tools have been developed by DESE and advocacy organizations to help with this


